### Transparency and Confidentiality

SVA is a public authority and is therefore subject to the principle of free access to public documents and the rules on official documents. By sending us a referral, you can also request that information about the assignment be kept confidential and that information (such as test results) be provided only to you and any recipients specified in the referral. ### Personal data processing

SVA processes personal data in accordance with the General Data Protection Regulation (GDPR).
